Spring 2011 Season Information & Registration Form

What: In-line hockey league with divisions for co-ed youth ages 5 – 18 and recreational adult players participating at their ability level. Divisions will be determined after registration, but we expect to have Atom, Pee wee, and Bantam playing with a hockey ball. Bronze and Silver will play with an inline puck. Bantam division to be determined based on number of registrants.

When: The season will run from April.5th until late June/early July. Game nights will be Tuesday + Thursday nights for all divisions. Game time will be 5:30-5:45pm for Atom, Pee wee & Bantam divisions. Bronze and Silver division games will be played in mid to late evenings.

Where: Atom, Pee wee, Bantam & Bronze divisions will play at Landing Sports Centre on Spadina Ave behind Prospera Centre in Chilliwack. Silver divisions and select Bronze games will play at Prospera Centre and/or Twin Rinks on Tyson Rd. in Sardis.

Who: Male and female players of all ages & abilities. Ultimately, the placement of players is determined by ability. Players with ice hockey experience are often 1 - 2 years ahead of other players. Generally, Atom division is 5 - 9 year olds, Pee wee division is 9 - 12 year olds, Bantam is 13-16 years old and Bronze is 16-19 year olds plus recreational 'B' & 'C' level adults. Parents are encouraged to register and play on a team with their child in Bantam & Bronze divisions. Silver division is for adult and elite youth players.

Why: Fun, fitness, fellowship, fair play, finesse & development of individual and team skills. Players learn to win and lose gracefully, and develop their character for a lifetime of enjoyment in sports.

NOTES: Length and number of games will depend on registration numbers. We'll start out with exhibition games to orient players and balance teams. Players may register as individuals or complete teams; however, GLIHL reserves the right to move a player or team up or down a division in the interest of safety and team balance. Bronze teams must have a balance of young and experienced players. All players are required to sign a waiver form. First time female players are half price. Parents are encouraged to play on a team with their children. Goalies are required to wear in-line skates, and are encouraged to register early to insure a spot. Focus in peewee will be on player positioning and team play. Atom will focus on individual in-line hockey skills. Players will have opportunities to move up to peewee as they become ready.
